### 1. BACKGROUND OF THE ORGANIZATION

Action Against Disasters Somalia (AADSOM) is a national, non-for-profit humanitarian organization that is committed to save lives, alleviate suffering, and maintain human dignity in the face of man-made and natural disasters in Somalia. AADSOM was established in 2008 by a group of local professionals with a cumulative experience of over 20 years in the fields of humanitarian aid and development. AADSOM's key thematic areas of intervention include Water, Sanitation and Hygiene (WASH), Food security and Livelihoods (FSL), Health and Nutrition (H&N) and Education. AADSOM seeks to bring about a paradigm shift on all its key thematic areas through greater mainstreaming and focus on the following cross-cutting themes: gender equality and environmental protection. This is because AADSOM firmly embraces gender mainstreaming as a strategy towards realising integration of gender perspectives into the preparation, design, implementation, monitoring and evaluation of programs, policies, and regulatory measures, with the view of promoting equality and accessibility between women and men henceforth combating gender-based discrimination in the humanitarian context. The organization advocates for impartial and unconditional aid delivery to affected communities in order to reduce the devastating impact of crises on the lives, livelihoods, and well-being of the communities it serves.

AADSOM carries out targeted humanitarian interventions and development projects in Somalia with particular focus in Banadir region, Hirshabelle, Southwest and Puntland states of Somalia and has reached and extended humanitarian interventions to more than a million affected communities in those states of Somalia and Banadir region through emergency relief projects and community-enhancing initiatives.

### 2. OBJECTIVES OF THE ORGANIZATION

Rapid and effective humanitarian response to emergency situations and to ensure sustainable livelihoods support to boost – crises transition areas in the country through the provision of direct service delivery, technical assistance/consultation, field-based research/dissemination, and indigenous community empowerment through capacity building initiatives.

The service provider/supplier and or the contractor shall report to the concerned logistics Unit/Project Manager and Operation manager of Action Against Disasters Somalia based on field, regional and or head office.

AADSOM now invites the eligible logistic suppliers to indicate their interest in providing the Services. Interested suppliers should provide information demonstrating that they have:

1. The required qualifications and relevant experience support documents.
2. The capacity to perform the Services-brochures, description of similar assignments, experience in similar conditions in the past.
3. Availability of appropriate skills among staff.
4. Evidential support documents of zonal operation throughout Somalia.
5. Valid registration both federal and regional levels. Core business of the company/firm and years in business.
6. Specific experience in successfully implementing similar assignments (developing communication strategies and implementation plans)
7. Experience of relevant services in an environment similar to where AADSOM operates (Puntland and South-Central Somalia)
8. Technical and managerial organization of the firm (provide only the structure of the company, general qualification and number of key staff). Do not provide CVs of key staff. Key experts will not be evaluated at the shortlisting stage.
